

JUNIOR CHALLENGE REGULATIONS

1. INTRODUCTION

The present conditions of participation describe the specifications on which the event called Junior Challenge 2019 will be developed (hereinafter the Event) composed of several distances: 200m, 600m and 1000m.

Any incident not collected in them, will be resolved by the Technical Director of Challenge Madrid, the Race Director of Challenge Madrid and a Representative of the City Council of San Martín de Valdeiglesias.

These conditions can be corrected or modified at any time by the Organization with due communication to the participants and periods of claim and resolution of incidents, being always recorded in them the date of modification.

The fact of making the registration in any of the modalities of the event shows the conformity of the participant with the totality of the content of the present conditions.

2. THE RACE

a. The event is organized by Challenge Madrid U.T.E. the City Council of San Martín de Valdeiglesias with the collaboration of different entities, companies and volunteers.

b. The date of realization will be September 21st, 2019 with departure and arrival in the Municipality of San Martín de Valdeiglesias.

c. Participation will be open to federated and non-federated participants.

d. Insurance coverage is guaranteed during the test for all participants.

e. The organization reserves the right to modify the content of these conditions provided that the security of the test and the integrity of the participants and the organizers so advise.

g. The departure time will be at 12.30 the first distance.

3. PARTICIPANT

a. The communication of the organization with the registered person will be made through the contact channels provided in the registration form. The Organization will assume that this communication process is being supervised by an adult and that the information transmitted through these channels is being correctly assimilated by the minor.

b. Each participant must identify himself to the organization at the time of the collection of bib numbers by DNI or Passport and must present the corresponding authorization of minors signed by the father, mother or legal guardian (hereinafter Authorizing Person) who will know all the conditions of this regulation.

- c. The authorizing person will give agreement that the participant complies with all the conditions included in this regulation and will confirm that the minor's health status allows him to complete the proposed route.
- d. The organization is not obliged to carry out any checking of the state of health, physical condition or training. Participation in the Event will be entirely and exclusively the responsibility of the authorizing person.
- e. The registered person will be covered by an insurance policy arranged by the Organization. The insurance will not cover pathologies or latent injuries, imprudence, negligence, non-observance of the laws or of the Rules and Regulations, etc. nor the accidents that may occur during transfers to and from the place where the race will be held. The Authorizing Person may obtain a copy of the terms and conditions of the referred insurance policy by requesting it from the organization via email.
- f. The Organization, any company, group and / or person that provides a service for the event, or that in any way collaborate in the Event, will not be liable to the person registered for any type of loss, damage, cost or claim, and is direct, indirect or that may result from participation in the Event, the transfer to and from the Event or any personal property that the person enrolled carries or uses in the Event.
- g. During the Event, the registered person will be able to receive medical attention and advice from the medical personnel designated by the Organization for the Event and, where appropriate, the Organization will assure its transportation to and assistance with a hospital.
- h. The person enrolled through the Authorizing Person has the right to refuse medical attention and advice from the medical staff of the Event.
- i. If the medical staff of the Event considers and motivates the Organization that participation in the Event may pose a risk to the health of the person enrolled, the Organization will exclude it from the Event.
- j. If necessary, the personal data of the registered person that constitutes medical information (either information referring to their condition or physical or mental health) can be computerized only by the medical staff of the Event to give medical assistance in the Event; said process shall only be carried out by the medical personnel subject to the duty of professional secrecy together with the rest of the guarantees provided in the applicable legislation.
- k. At the time of the collection of the bib number, through the Authorization of Minors the registered person must deliver the corresponding Responsible Declaration. This document will be accessed:

- l. The bib number will not be given to those people who do not present the Authorization of Minors duly signed at the moment of the collection of the same.

4. THE ROUTE

- a. The route will be properly delimited in its entirety with clearly visible elements arranged by the organization especially for the race.
- b. There will be a refreshment at the end of each race.

5. CONDITIONS OF REGISTRATION AND PARTICIPATION

5.1. INSCRIPTIONS

- a. Each participant can register in one of the three distances proposed for the Junior Challenge.
- b. The registration period will be from May 1st, 2019 to September 16st, 2019. No registration made after this period will be accepted.
- c. Registration will be effective:
 - Paying the registration fee that is 2 euros
 - On-line filling in all the fields of the authorization available in [LINK Download authorization of minors](#), and sending it to info@challenge-madrid.com, or giving this authorization in the bib numbers.

e. A limit of places of 200 participants is established.

f. The registration entitles you to:

- Participate in any of the three distances.
- Circuit correctly delimited.
- Insurance coverage of the test.
- Finisher medal.
- Solid and liquid provisions.
- Assistance by health and safety personnel.
- Medal for the first three classified in each category.

6. IMAGE AND PERSONAL DATA

Once the registration of the participant has been formalized through the Authorizing Person, the transfer of exploitation rights to CHALLENGE MADRID U.T.E. on the audiovisual recordings, photographs and on the broadcasts, broadcasts and / or retransmissions of the CHALLENGE MADRID event and of the participants in this event, will be worldwide, exclusively, with the power of exclusive assignment to third parties, in accordance with the maximum time allowed. allow the Intellectual Property Law and for all the rights of recording, public communication, reproduction, distribution and transmission, and by any technical means, system or format expressly included, in an

enunciative and non-restrictive way, terrestrial transmission, both digitally and analog, cable, satellite, and in general by any procedure of broadcast, transmission and retransmission, and under any broadcasting system, open television, encrypted, pay-tv, pay per view, video on demand, video near on demand, videocassette, laserdisc, videodisc, CDI, CDI-DV, CDRom, DVD, home video, mobile telephony, internet and multimedia systems in any form and, in general, by any type of exploitation modality known or that may be known in the future.

On the basis of the foregoing, CHALLENGE MADRID U.T.E. will be the owner of all rights of exploitation, in any form of exploitation, complete and / or partial, of the images and photographs produced of the event and its participants.

7. CATEGORIES

a. The categories will be the following:

Prebaby	up to 5 years	200 meters
Mini benjamin	from 6 to 7 years	200 meters
Benjamin	from 8 to 9 years	600 meters
Alevín	from 10 to 12 years	1000 meters
Infantil	from 13 to 14 years	1000 meters

b. To establish the categories, the participant's age will be taken as reference on the day of the test.
